Founded in response to the 2008 Economic Recession, our organization has empowered countless individuals to overcome financial crises and achieve lasting financial freedom through education, direct services, and strategic referral partnerships.

We understand the immense challenges faced by lowand moderate-income households in our region, as they navigate rising rents, mounting debts, and economic uncertainty. These pressures have pushed many to the brink, but with proper support, we can help them reclaim stability and build a brighter financial future.

Our Work

Service Area

Haven Neighborhood Services is deeply rooted in South Los Angeles at Mercado La Paloma, extending its reach across Los Angeles and neighboring counties to meet communities where they are. Through strategic satellite offices and partnerships with organizations such as the Department of Veterans Affairs, City of Santa Monica, UC Riverside, and multiple FamilySource Centersincluding All Peoples Community Center, Barrio Action Youth & Family Center, El Centro del Pueblo, El Nido Family Centers, and Watts Labor Community Action Committee-we bring our mission to life. To ensure no community is left behind, we provide free tax services and financial workshops in collaboration with trusted partners and host numerous pop-up locations during tax season throughout Los Angeles, Riverside, San Bernardino, and San Diego counties. By breaking barriers to access, we empower individuals and families with the tools and support needed to achieve financial stability and independence.

Service Population

We are dedicated to uplifting 100% Low- and Moderate-Income (LMI) individuals and families through no-cost financial education workshops and direct services. Our impact spans a diverse range of vulnerable populations, including At-Risk Youth, Domestic Violence Survivors, Justice-Involved Individuals, LGBTQ+ members, Seniors, Transitional Age Youth (TAY), Undocumented Immigrants, U.S. Military Veterans, and more. By addressing the unique challenges of each group, we empower individuals to overcome barriers, achieve financial stability, and thrive.





Success Story:

Kemverly Limon



To Kemverly's surprise and relief, not only did she not owe, but she was eligible for a combined federal and state refund of \$5,979.

On April 15—the final day to file taxes without penalty— Kemverly Limon visited Barrio Action to file her taxes for the first time in several years. As a stay-at-home mother who recently returned to the workforce, she had avoided filing due to uncertainty and fear of owing back taxes. Adding to her concern, she had heard from others—some with justice-involved backgrounds—that tax filing could be risky. Understandably, Kemverly arrived feeling anxious and unsure.

Despite the bustle of a busy tax day, Kemverly remained patient and open, trusting the process with our VITA (Volunteer Income Tax Assistance) team. She worked with Erendira, our site coordinator, who walked her through each step with care and clarity. To Kemverly's surprise and relief, not only did she not owe, but she was eligible for a combined **federal and state refund of \$5,979.**

Her reaction was full of gratitude:

"I don't care how long it took—this service was worth the wait. I'll wait longer just to sign."

Erendira took extra time to explain why Kemverly qualified for the refund, including the role of the Child

Tax Credit and proper tax withholding. She also assured her that Haven and Barrio Action's teams would be available to answer future questions.

As a new client, Kemverly also learned about other services available through the FamilySource Center, such as food distribution, academic tutoring, and tenant support. She expressed particular interest in services for parents and children and was connected with staff for a follow-up conversation.

By the end of her visit, Kemverly left not only with a substantial refund but also with a renewed sense of financial confidence and a new support network. She plans to return to explore more services and take further steps on her financial wellness journey.

Free Tax Preparation Services -FreeTaxPrep

Through the IRS Volunteer Income Tax Assistance (VITA) program, we offer no-cost tax preparation and ITIN application services to low- and moderate-income individuals and families. Our certified trained staff and volunteers ensure accurate and timely filing, helping clients maximize refunds and access credits such as the Earned Income Tax Credit (EITC). This service not only increases annual income but also serves as an entry point to other financial empowerment programs we offer.



Partnership.LA

Haven Neighborhood Services is the managing organization of the Partnership. LA Initiative & Annual Summit. Each year this collaborative works to provide opportunities and resources to small and medium sized nonprofits working in the economic development space. Through a variety of webinars, workshops, and online forums that culminate in an annual summit, Partnership. LA aims to gather nonprofit staff, community stakeholders, and agency leaders from across Southern California to foster and enhance inter-organizational partnerships. Partnership and collaboration are cornerstones at Haven Neighborhood Services, providing the ultimate piece of our holistic methodology. Success Story:

Evangelina Kashekya



Evangelina's dedication paid off. She had reduced her credit card balances by an impressive \$7,000.

Evangelina Kashekya, a dedicated caregiver and grandmother of three, has lived in Santa Monica for over eight years in a modest two-bedroom apartment. Supporting her family through her work with IHSS and small side jobs, Evangelina faced mounting financial stress when her credit score began to decline. Unsure of how to address the issue, she turned to a friend who had attended a Haven Neighborhood Services Financial Literacy workshop at Virginia Avenue Park. Encouraged by her friend's recommendation, Evangelina reached out to Haven for help.

In March 2024, Evangelina began her journey with Haven Neighborhood Services by meeting with Financial Coach Diana Arciniega. During their first session, Diana conducted a comprehensive intake process, including a review of Evangelina's credit report and score. Together, they set smart financial goals: improving her credit score and saving for a future home purchase. The review revealed that an auto loan Evangelina had cosigned was three months delinquent, and her credit card balances exceeded the recommended 30% utilization rate. Diana explained the impact of these factors on her credit score and worked with Evangelina to create a personalized budget, empowering her to make additional payments and monitor her progress. Evangelina committed to regular coaching sessions, determined to improve her financial health. By May 2024, Evangelina's dedication paid off. She had reduced her credit card balances by an impressive \$7,000, which led to a significant increase in her credit score. Although her delinquent auto loan was sent to collections, Evangelina is proactively working to resolve the balance. With her newfound financial knowledge, she is focused on timely payments and continuing to reduce her debts.

Evangelina's story is one of perseverance and transformation. With Haven's guidance, she has not only improved her credit score but also gained the confidence to pursue her dream of homeownership. Evangelina is grateful for the personalized support she received and is excited to continue her journey toward financial empowerment.

Success Story:

Donnell Lewis



Donnell began to pay down his balances, and over a few months, his credit score improved from 569 to 612.

Donnell "Little One" Lewis, a proud U.S. Army veteran, knows what it means to fight both on and off the battlefield. After serving his country with honor, Donnell faced a difficult transition back to civilian life—battling PTSD, physical disability, substance abuse, and years of housing instability.

Caught in a cycle of starting and stopping support programs, Donnell often found himself back at square one. Despite his resilience, the setbacks took a toll on his hope and progress.

That began to change when Donnell connected with Haven Neighborhood Services and met his financial coach, **Lindsey Flores**. With empathy and patience, Lindsey became a constant presence in Donnell's life offering more than just financial guidance.

"These men and women have sacrificed so much for our country," Lindsey says. "They deserve a little patience."

Together, they began the slow and steady process of rebuilding. Donnell's credit score was once 569, burdened by collections and delinquencies. With Lindsey's support, he started budgeting, tackling debt, and developing consistent financial habits. In just a few months, his score climbed to **612**, and—more importantly—he began to feel confident in his financial future.

Thanks to the collaborative efforts of the **VA and Haven**, Donnell now lives in **stable housing**. He's continuing to pay off debt and is working toward **homeownership by the end of the year**—a milestone he once thought impossible.

Donnell's story is one of grit, transformation, and the power of personalized support. Through his determination and Lindsey's unwavering guidance, he's reclaiming his life—one step at a time.
